



Sheltered vs. UnSheltered






As of June 2016, 274 People were experiencing chronic homelessness

Where we started and how far we have come

THE BEGINNING

- "Implementing "Housing First for a number of years
- ► Largely a sheltering system vs. a housing system
- Deep assessments and multiple requirements for service participation
- ▶ Treatment first model
- ▶ Risk adverse

FINDING COMMON GROUND: THE "SPIRIT" OF HOUSING FIRST

- Immediate access to permanent housing with no readiness requirements
- ► Consumer choice and self-determination
- Recovery orientation
- ► Individualized and client-driven services
- Social and community integration

CHANGING HEARTS AND MINDS

- ▶ Listen, really listen!
- Discuss If you haven't had the same conversation at least 5 times, keep trying
- ▶ Build on momentum
- ► Look for unlikely allies
- ▶ Use the hammer, sparingly
- ▶ Find a support system change is exhausting

TACTICAL TOOLS

Okay, but how?



- In Montgomery County, 6% of the population is in poverty but less than 0.1% become homeless!
- Only 1 out of 4 households that need a housing subsidy get one.
- In Montgomery County, 50% of households experiencing homelessness are employed.
